

## WINDOW TINTING

The manufacturer warrants all Beam Window Tinting against bubbling, cracking, peeling, scratch resistant (SR) coating breakdown, delamination from glass and demetallising from the date of the original application for the Lifetime of the vehicle. If the film fails to comply with this warranty, the manufacturer or its distributor will replace such quantity of film as proved defective (including labour). No liability is assumed for scratching or other damage to the film caused by improper treatment or from glass breakage from any cause or any consequential damage. This warranty is void if the film is subject to abuse or improper care in particular the warranty shall not apply if the film has been subjected to mistreatment such as picking at edges, cleaning with abrasive or ammonia-based products. This warranty is not transferable.

## CARE FOR YOUR TINTED GLASS

- Do not open windows for 48 hours after installation.
- Do not clean glass during drying period, (21 days)
- To clean, spray film with soapy water and wipe off lightly with soft cloth. Do not use abrasive cloths, brushes, powders, or ammonia-based cleaning materials.
- An almost invisible splice may appear on windows which require two or more sections of film. This is not a fault in the film.
- The barely visible clear border around the edges ensures that the film is properly bonded to the glass.
- A milky appearance caused by water between film and glass will disappear along with any bubbles.
- A few small "points" may remain. These are generally visible from the outside and inherent to film adhesives. These points do not affect the performance of the film.
- The silver effect caused when film is applied over the ceramic "black dots" that surround some glass is normal and not a fault of either film or application. The performance of the film is not affected.

## **GENERAL CONDITIONS**

Beam-Endrust is pleased to provide a 10 Year Nation-Wide Warranty from the date of vehicle manufacture on all its surface protection products in accordance with the terms, conditions and exclusions contained here-in. The benefits conferred under this warranty are in addition to the rights and remedies conferred under the Australian Consumer Law (ACL). This warranty does not apply unless the consumer agrees that they have read the warranty, fully understands it and accepts the entire context thereof, (Warranty valid only if signed).

This warranty shall be deemed void or redundant:

- at the expiration of the term of the warranty shown herein.
- if the treated vehicle leaves the Australian territory for any reason.
- if the vehicle is subjected to unreasonable owner abuse or neglect.
- If the vehicle was more than 5 years of age at the "Date of Application" shown here-in. (The "Vehicle Build Date" will be used to determine vehicle age).
- If the vehicle is subject to a valid and enforceable manufacturer's warranty at the time of any warranty claim.
- if the owner ceases to be the registered owner of the vehicle, (warranty is not transferable).

- if the vehicle becomes un-registered for longer than 3 months.
- if damage to the vehicle such as but not limited to collision, chemical or acid spills, fire, water immersion, hail or similar has occurred and the damaged areas have not been professionally repaired and retreated (where applicable) by an authorised Beam-Endrust Applicator within one month of repair work.
- if an issue is found to be due to defective workmanship and materials used in the manufacturer of the vehicle.
- if the vehicle (of any type) is used for special purposes in extreme conditions, for example but not limited to - Beach lifeguard, Mining and Construction, Carriage of hazardous or corrosive chemicals, Professional fishing, Subjected wholly partly to salt water (other than beach use for recreational purposes).

## **RUST PROTECTION**

The Beam-Endrust "Spray-on Chemical Rustproofing" and "Electronic Rust Protection Systems" are warranted to help protect vehicles against steel corrosion. Should the treated vehicle corrode then Beam-Endrust shall undertake appropriate remediation of the corroded area at no cost to the vehicle owner subject to the terms, conditions and exclusions contained here-in.

This Warranty does not cover: -

- rust arising from chipping or flaking paint anywhere on the vehicle, or where plastic or rubber body mouldings come in contact with the metallised body panels. Note: the brown (ferric oxide) stain that develops on and around paint chips should be cleaned and repainted at the consumer's earliest convenience.
- rusting of chrome plated trims, Engine, Ancillary Fittings, Auxiliary Fittings, Power Drive Train, Exhaust System, Brake System, Electrical System, Suspension, Heating System, Cooling System and all fittings and fastenings associated with these components.
- rust inside vehicle load areas (i.e., utilities and vans).
- any metal components which are not or should not be treated with spray-on rustproofing as per Australian Standard AS2662.2. For example, but not limited to the Exterior Body Paintwork and Roof area.

## PAINT PROTECTION

Beam-Endrust Paint Protection is warranted to help reduce the loss of gloss to the treated areas because of exposure to normal weather conditions and eliminate the need to wax or polish the treated areas for the term of the warranty. If the product fails to comply with this warranty, Beam-Endrust will clean or buff (at its discretion) the external painted surfaces where it can be shown to have failed including re-application of the protection treatment. Provided that:

- no accidental damage, stone chipping, contact with chemicals or bore water, harsh detergent or salt brine areas, damage from car wash brushes, vandalism, scratches have occurred.
- the vehicle is reasonably maintained including regular washing and removal within 24 hours of all tree sap and bird droppings etc.

## FABRIC • VINYL • LEATHER PROTECTION

Beam-Endrust warrants that should the treated areas become permanently stained or soiled. Beam Endrust will clean or replace (at its discretion) the affected area.

This Warranty does not cover:

• stains, soiling, or damage caused by acid, dye, ink, bleach's, solvent, gum, paint, burns, tears, rips, cracking vandalism, or neglect.

## **OWNERS OBLIGATIONS**

The owner acknowledges that the Beam-Endrust surface protection products can only protect their vehicle for so long as the products remains intact and fully covering the surface where first applied.

The owner accordingly undertakes to personally or via a competent and qualified third party to periodically check that the surface protection products are fully intact and have not been damaged or compromised in any way. Missing or damaged Rustproofing should be touched up without delay.

We recommend you update the "Inspection & Service Record" after each inspection, re-application or servicing which is undertaken. This information may be referenced to confirm the validity of a future claim.

## LIMITATION OF LIABILITY

The total cost of repairs during the Warranty period is limited \$2,500.00 with a maximum of \$500.00 per any one claim. The Warranty does not cover costs incurred due to the loss of use of the vehicle, rental car expenses or any other incidental or consequential loss or damages.
